#### 1.0. PURPOSE

**1.1.** This document defines the provisions required by the FRC Corporation Quality System as a means of satisfying the requirements of AS9100.

- **3.2.** Group "B" requirements are specific to either a product or service provided by some suppliers and do not apply to all suppliers for this reason. When these products or services are a part of the purchase order, group "B" requirements shall be referred to on the purchase order.
- 3.3 Any exceptions to applicable requirements contained in this document must be authorized in writing by FRC Purchasing. Any approved exceptions must be retained for later possible review by FRC, their customer or an applicable regulatory agency.

#### 4.0. GROUP "A" REQUIREMENTS

# A1 RIGHT OF ACCESS (All purchase orders)

The supplier shall afford the right of access by FRC, their customer and any applicable regulatory agencies to all facilities, at any level of the supply chain, and quality records involved in the fulfillment of the applicable purchase order.

### A2 CHANGES IN PRODUCT OR PROCESS (All purchase orders)

#### A6 CERTIFICATE OF COMPLIANCE

## A8 RETENTION OF QUALITY RECORDS (All purchase orders)

Inspection and test records for products sold to FRC shall be retained for a period of no less than 12 years.

### A9 NONCONFORMING PRODUCT NOTIFICATION AND APPROVAL

(When the subject product in a PO is nonconforming)

When non-conforming product is identified, suppliers to FRC are responsible to:
